Dear Parents/Caregivers

### Publicity/Media Productions

Our school would like to take photos and or videos of students during the year in order to promote pride in student success, display activities and performances undertaken at school, during external activities and excursions and to also promote public education. Photographs may be placed in the school newsletters, website, facebook, Blogs, powerpoint presentations and posters. Occasionally this includes inviting the local media to special events throughout the year. This may be in the form of a television report, or as a photo and brief article in the newspaper. The children's names usually accompany photos in newspapers.

### PG Rated Movies

DEC regulations state that **all school students** are only able to watch G rated movies at school without parental permission. At times we may want to watch a PG rated DVD. If your child's class watches a PG rated DVD the teacher will have viewed the DVD and deemed it suitable for the class.

### Child Protection.

This is an area of study undertaken by classes during the year. Lessons will involve discussing body parts and stranger danger.

### Short Walking Excursions

There will be times during the year when students will participate in short walking excursions near the school. This could include, walks to the lake or to a park. Students will be supervised by classroom teachers.

### Internet Access

Students will access the internet in classrooms and the computer laboratory. This can include video conferences in our connected classroom. Internet access will be taken under the supervision of the classroom teachers and school Learning Support Officers.

### The Spider/Playground Equipment

Our students should only be using "The Spider" and Play Equipment under direct supervision of a classroom teacher. If parents or caregivers would like their child/children to use the spider and Play Equipment under supervision of staff, please complete below.
